Trailers for Yard Debris

Trailers may be checked out by a homeowner to load yard debris. These trailers are to be used for the collection of limbs, leaves, and yard debris only. (Household debris cannot be mixed in trailers with yard debris). All tree limbs and trunks left for the City to pick up are required to be cut in sections not exceeding 6 feet in length and cannot weigh over 50 lbs. each. If a homeowner pays a contractor to cut trees or shrubbery on their property, it is the responsibility of the contractor to dispose of the clippings that derived from the property.

Trailers for Household Debris - County Landfill

Trailers can be used to load large household items (i.e. stove, dishwasher, washing machine, clothes dryer, microwave, computer, couch, chair, mattress & box spring, carpet, disassembled kitchen and bathroom fixtures, etc.). Items containing asbestos cannot be placed in the trailers. (Yard debris cannot be mixed in trailers with household debris) Refrigerators, freezers, air conditioners or items containing Freon cannot be placed in trailers.

Trailers for Building Material

Trailers for building material (i.e. sheetrock, drywall, plywood, paneling, hard wood flooring and linoleum flooring) are available to the homeowner and is to be used only by the homeowner. A minimum charge of \$150 per trailer/load will be charged and collected upon check-out of the trailer. If the dumping costs exceed the \$150 minimum, the homeowner will be responsible to pay the difference.

The City will NOT accept or dispose of the following items: Bricks, Asbestos Shingles, Tires, Cement, Paint Containers.

Additional Information

Homeowners will be allowed two (2) free trailer usages per property, per year, for the disposal of yard debris and/or household debris. After the two free usages, property owners can check out a trailer for yard or household debris at a cost of \$50 each. The homeowners' city taxes must be current at the time a free usage is issued.

Note:** Trailers will be left at the end of each working day and picked up at the beginning of the next working day. Trailers are not to be moved by anyone except city personnel. The homeowner will be responsible for any damages incurred to the trailer while on the homeowner's property. Trailers for any and all usages are not to be overloaded with debris in order to prevent damage to the trailer and the truck. **If an overloaded situation occurs, the contents of the trailer will be dumped on the homeowner's property prior to it being moved by the city.


